## **Scorpio Tankers Inc. Announces Purchase of Call Options by President of the Company**

MONACO, August 11, 2021 (GLOBE NEWSWIRE) — Scorpio Tankers Inc. (NYSE:STNG) (“Scorpio Tankers,” or the “Company”) announced that the President of the Company, Robert Bugbee, has purchased call options on an aggregate of 100,000 common shares (or 1,000 call option contracts) of the Company for total consideration of \$448,000. The call option contracts have a strike price of \$15.00 and an expiration of January 2023.
